Subject: Physician Impersonation Event

On January 11, 2018, at approximately 10:00am, a male adult of Middle Eastern decent was approached by Security in the Doctor's lounge of Sharp Grossmont Hospital in La Mesa, California. The male subject was wearing blue scrubs and wearing a physician's jacket embroidered with the Sharp HealthCare logo and the name "Zaid Jorge, MD Anesthesiologist." The subject was also in possession of a stethoscope, a cell phone with Arabic messages visible on the screen, and a set of rental car keys to a Mercedes Benz. The male subject had no credentials or any Sharp identification, and when contacted by Security for the lack of credentials, the subject said that he was a student in Sweden and was here to learn more as part of his student apprenticeship. When asked if he had a sponsor, liaison, or escort, he gave the name of a Grossmont Hospital physician (Nassir Azimi), but when that physician was contacted, the physician said that he didn't really know this individual. He said the subject seemed to have latched on to him a few weeks ago after he accepted a connection request from the professional web site, LinkedIn. None of the other physicians in the lounge were able to identify this subject as part of the hospital staff. When asked how he got to the hospital today, he said that he drove his car and parked it in the Grossmont Center Shopping Mall parking lot across the street.

The website LinkedIn was viewed and a profile of this individual was found (see attached). The LinkedIn profile described the subject as a graduate of Harvard School of Medicine and as an Employee of Sharp HealthCare as a Medical Doctor for over a year. The LinkedIn profile also contained a photo of the subject inside a Sharp medical facility (unknown location) working on a computer.

La Mesa Police were notified and sent units to evaluate. Attempts were made to contact the local Joint Terrorism Task Force (FBI), but they requested an evaluation by La Mesa Police first. La Mesa Police arrived at about 11:00am and brought a PERT unit with them. PERT evaluated and determined the subject did not meet the criteria for a 5150W&I hold. Police continued to evaluate as potential terrorism activity, to include terrorism surveillance, terrorism security testing, and terrorism dry runs. The subjects

rented Mercedes Benz was located in the main hospital parking lot (CA#7WSF853), and police were able to search it for evidence. Inside, they located copies of two (2) separate passports and a local address out of El Cajon.

Police subsequently arrested the subject, identified as Zaid Jeorge, on impersonation charges (529PC). When a request was made for a restraining order in this case to protect the hospital and/or Doctor Azimi, police had indicated that Sharp legal would need to initiate that process through the court, and that field officers could not issue any such protection order.
